6	WHEREAS, Ordinance No. 900, effective on July 1, 1996, presently codified as Section 18-42 of Code of Ordinances of the City of Glasgow, authorizes the City Council to direct the
7	City's Director of Public Works to place new traffic control devices or to modify existing traffic control devices; and
8	WHEREAS, the City has installed additional signage and traffic control devices in
9	accordance with the requirements of the City of Glasgow and the Montana Department
10	
11	NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLASGOW, MONTANA:
12	Section 1: That Ordinance No. 900 be amended as follows:
13	
14	Sec. 18-41. Existing traffic control devices enforceable.
15	All traffic control devices, including signs, signals, markings, parking spaces, and devices
16	not inconsistent with this chapter, in existence on the date ordinance no becomes
17	effective [], are declared to be "official traffic control devices" and are
18	enforceable. It shall be unlawful for any person to violate any provision or to fail to comply with
19	any requirement of this chapter.
20	Repealer
21	Section 2: All resolutions, ordinances and sections of the Municipal Code and parts thereof
22	in conflict herewith are hereby repealed.
23	Saving Clause. Section 3: Ordinance No. 900, amended by this ordinance, shall remain in force to
24	authorize the arrest, prosecution, conviction and punishment of a person who violates Ordinance
25	No. 900 prior to the effective date of this ordinance.
26	Effective Date Section 4: This ordinance shall be in full force and effect thirty (30) days after final
27	passage and approval.
